

Contract of Enrolment and Registration – September 2010 to June 2011

Instructions



1. Complete the **Contact Information** overleaf, including name, address, phone, and email.
2. Check the appropriate box for **Canadian Resident or Non-resident**. If Non-resident please contact the school office at 250-352-6919.
3. Complete the **Tuition** section of the form using the following criteria:
 - a. **Full Tuition Rates** are \$3300 for Kindergarten and \$5875 for Class 1-8.
 - b. There are **Sibling Discounts**, meaning that the oldest child pays full tuition (100%), the second oldest child pays 50%, the third oldest child pays 33%, and the fourth oldest child pays 25%. Use the table to calculate the total discounted tuition for all children in Line 1.
 - c. **Tuition Reduction** is available as follows. Calculate your family's total 2009 net income (from Canada Revenue Agency Notice of Assessment Line 236) on Line 4 and multiply this by 11% to find your maximum family tuition on Line 5. Your net tuition payable is the amount from Line 1 or Line 5, whichever is smaller. Applicants must attach a copy of the 2009 Canada Revenue Agency Notice of Assessment for each member of the family.
 - d. If this is your first year in Class 1-8 at the Nelson Waldorf School, you are eligible for a **Tuition Scholarship** (free tuition). Please contact the school office for details.
4. Complete the **Supply Fee** section of the form (Kindergarten: \$250, Class1-5: \$350, Class 6-8: \$475).
5. Complete the **Early Payment Discount** section of the form. If you pay your Tuition and Fees by June 15, 2010 you receive a 5% discount.
6. Complete the **Administration Fee** section if applicable (\$100 one-time fee per family), and the Society Dues section (\$1 per family per year).
7. Calculate the **Total Amount Payable** (due June 15, 2010 if claiming the Early Payment Discount, or August 31, 2010 otherwise).
8. If there are **Exceptional Circumstances** that you would like the Board of Directors of the Nelson Waldorf School to consider in relation to tuition arrangements for 2010 please contact the school office.
9. Complete the **Parent Involvement/Volunteering Form**. Your application will be considered incomplete until this is returned to the school office.
